Where the nominations for a position, received by 12 October, are equal to or less than the number of positions available, such nominees are elected unopposed. If the number of nominations had been greater than the number of positions available, a ballot would have had to be conducted. Nominations for any unfilled positions (i.e. two Executive Officers) shall be taken from the floor of the meeting. As a person can only hold one position on the Management Committee, any person who has nominated for two positions will automatically cease to be a candidate for the 2nd position if elected to the 1st position.

Elections for the positions of President, Vice-President, Hon. Secretary and Hon. Treasurer are conducted by preferential secret ballot. Elections for the position of Executive Officer are conducted by a first-past-the-post secret ballot.

Only Ordinary Members and Hon. Life Members, who are present at the AGM, can vote in the elections. Junior and Associate Members do not have voting rights. Proxy votes are not allowed. Ordinary Members are persons (18 years of age or older) who are current UQ Students, current UQ Staff, UQ Graduates and Non-graduate ex-UQ Students (enrolled for at least 3 semesters).

Those elected to the Management Committee at these elections will hold office from the conclusion of the 2009 AGM until the conclusion of the 2010 AGM.
